



## TERMS AND CONDITIONS

### of beach volleyball, bathing beach/beach in Hagenwerder

#### § 1 Recognition of the rules

Entering the courts, the visitor confirms that he has read and accepted the content of these regulations.

#### § 2 Permission to use

- (1) Volleyball courts are owned by KommWohnen Service GmbH, with its registered at Konsulstraße 65, 02826 Görlitz (hereinafter referred to as Operator)
- (2) The use of the courtes is possible for everyone under the conditions set out in these regulations.
- (3) Training and scheduled games according to the list (see the announcement board by the beach) take precedence over the previously unagreed, free use of the court.
- (4) Tournaments and special events usually take precedence. Dates can be seen on the announcement board.
- (5) The use of courts by children under 14 is permitted with the consent and responsibility of their parents or carers.

#### § 3 Opening hours

- (1) Operating hours are generally April to October. The space release / blocking is carried out by the operator.
- (2) Outside of working hours, the entrance to the beach volleyball court is not allowed.
- (3) The operator has the right to impose a ban on the use of the courts depending on the weather or the condition of the place.

#### § 4 Maintaining order and cleanliness

- (1) After use, the sand should be levelled with the supplied equipment. (All depressions and inequalities must be compensated.) Please note that the surface is left as horizontal as possible after use.
- (2) The sand must be kept free of foreign objects and dirt, if necessary they must be removed (e.g. stones, branches) and moved to nearby garbage containers.
- (3) It is forbidden throughout the courts:
  - smoking
  - grilling or smoking a fireplace
  - bringing / walking the animals
  - bringing / using glasses, glass bottles or other glass objects
- (4) Each user of the property is obliged to leave the place behind as orderly, clean area. Rubbish and waste must be thrown into the baskets located on the beach grounds.
- (5) Net damage or other damages should be immediately reported to the courts operator (Tel. 015114814075).

#### § 5 Power to issue orders

The instructions of the operator or by him authorized person must be executed immediately and without exception.

#### § 6 Violations of this terms and conditions

- (1) If you violate these terms and conditions, you may be excluded from the use of the courts or expelled from the property by the operator.
- (2) Criminal and liability laws remain unaffected.

#### § 7 Liability provisions

- (1) The operator is not responsible:
  1. in case of loss of personal items
  2. in case of damage to personal items by third parties
  3. in case of damages, accidents and injuries resulting from the operation of the court through his own fault of third parties fault.
  4. Entry and use of the court is always at your own risk.
- (2) The users are liable to the operator for caused damage, intentional damage to property and for any contamination of the court, whether it was the result of intentional act or negligence.

The Regulations will enter into force on 01. April 2020
